

### Tri-Care / Express Scripts

Tri-Care recently mailed out prescription home-delivery education "alert" letters to promote pharmacy home delivery. It focuses on the convenience and lower cost of home delivery versus retail pharmacies and includes information how to switch prescriptions over. Switching from retail pharmacies to home delivery spares the beneficiaries inconvenience of picking up their prescriptions and saves them 66% per prescription. Home delivery also saved the Department of Defense \$30 million in 2010.

### Walgreens Drug Store to Leave TRICARE Pharmacy Network

Walgreens drug stores have announced that, as of **January 1, 2012**, the chain will no longer be part of the network used by the TRICARE Pharmacy plan known as Express Scripts, Inc. (ESI). ESI is a Pharmacy Benefit Management (PBM) company that processes TRICARE pharmacy claims and manages TRICARE's Mail Order Pharmacy Program (TMOP).

Walgreens and TRICARE had a similar contractual disagreement in 2008, but the impasse was resolved before the expiration date of the contract. FRA is closely monitoring negotiations and will report any further developments. If the dispute is not resolved TRICARE beneficiaries filling a prescription at Walgreens after December 31, 2011, will pay 100 percent of the cost up front and then file a paper claim for non-network benefit reimbursement.

### VA expands outreach to women veterans

The VA is expanding outreach to women veterans and increasing awareness of the enhanced VA benefits and the services available to them. Today there are more than 1.8

million women veterans of all eras and one of the VA's highest priorities is to continue to expand our services and outreach to ensure they receive the care and benefits they have earned.

Today, more than 200,000 women are serving in the armed forces. About 11% of the U.S. forces currently serving in Afghanistan and Iraq are women.

### 2011 Retiree Pay Date Changes

Because of a provision in the 2011 National Defense Authorization Act (NDAA), paydays for military retirees are changing for SEP and DEC 2011. The 2011 NDAA requires military retiree pay to be processed on the first day of the month and when that day falls on a weekend or national holiday, the pay date is moved to the previous business day. This years payments of 03OCT11 will be issued on 30SEP11 and payment for 03JAN12 will be issued on 30DEC11.

For the calendar and tax year of 2011, this means military retirees will then receive **13 rather than the normal 12 payments**. Since the 13th payday on 30DEC11 falls within the 2011 tax year this could possibly affect the tax liability of some retirees and those who receive portions of their retired pay.

Retirees are urged to speak with a tax advisor, the IRS or their state tax authority to determine if their tax withholding will satisfy federal and state income taxes when they file returns next year. For tax year 2012 and beyond, retirees will receive their normal 12 payments.

**P-3 Orion Makes History**

We know now the outcome of the Libyan revolution, but many do not know that the P-3 Orion had a historical role in the beginning of the conflict. On 28MAR11, a P-3 flown by VP-5 "Mad Foxes" attached to Task Force 67, fired two AGM-65F Maverick guided missiles at a Libyan coast guard vessel who had been firing at civilian merchant ships off of the coastal town of Miarata. There are variants of the missile, but the one the Orion uses carries a 300 pound penetrating warhead and a infrared targeting system.

In operation with an Air Force A-10 and the Navy destroyer U.S.S. Barry, they sunk several vessels to protect civilians. This engagement wasn't the first time a P-3 fired a shot in combat but it definitely demonstrated its versatility along with the importance of early air dominance. While the Orion's days are limited, it shows that it is still a remarkable airframe after all these years.

It includes information about your allotments, income tax withholdings, direct deposit and a **Survivor Benefit Plan (SBP)** counter that shows plan members how much longer they have to pay premiums. ## **Folded Flag**



Understand what the flag draped coffin really means. Here is how to understand the flag that is laid upon it and is surrendered to so many survivors.

Do you know that at military funerals, the 21-gun salute stands for the sum of the numbers in the year 1776?

Have you ever noticed the honor guard pays meticulous attention to correctly folding the United States of America Flag 13 times? You probably thought it was to symbolize the original 13 colonies, but we learn something new every day!

- **1st fold:** is a symbol of life.
- **2nd fold:** is a symbol of the belief in eternal life.
- **3rd fold:** is made in honor and remembrance of the veterans departing the ranks who gave a portion of their lives for the defense of the country to attain peace throughout the world.
- **4th fold:** represents the weaker nature, for as American citizens trusting in God, it is to Him we turn in times of peace as well as in time of war for His divine guidance.
- **5th fold:** is a tribute to the country, for in the words of Stephen Decatur, "Our Country, in dealing with other countries, may she always be right; but it is still our country, right or wrong.
- **6th fold:** is for where people's hearts lie. It is with their heart that they pledge allegiance to the flag of the United States Of America, and to the Republic for which it stands, one Nation under God, indivisible, with Liberty and Justice for all.
- **7th fold:** is a tribute to its Armed Forces, for it is through the Armed Forces that they protect their country and their flag against all her enemies, whether they be found within or without the boundaries of their republic.
- **8th fold:** is a tribute to the one who entered into the valley of the shadow of death, that we might see the light of day.
- **9th fold:** is a tribute to womanhood, and Mothers. For it has been through their faith, their love, loyalty and devotion that the character of the men and women who have made this country great has been molded.
- **10th fold:** is a tribute to the father, for he, too, has given his sons and daughters for the defense of their country since they were first born.
- **11th fold:** represents the lower portion of the seal of King David and King Solomon and glorifies in the Hebrews eyes, the God of Abraham, Isaac and Jacob.
- **12th fold:** represents an emblem of eternity and glorifies, in the Christians eyes, God the Father, the Son and Holy Spirit.
- **13th fold:** or when the flag is completely folded, the stars are uppermost reminding them of their nation's motto, "In God We Trust."



After the flag is completely folded and tucked in, it takes on the appearance of a cocked hat, ever reminding us of the soldiers who served under General George Washington, and the Sailors and Marines who served under Captain John Paul Jones, who were followed by their comrades and shipmates in the Armed

Forces of the United States, preserving for them the rights, privileges and freedoms they enjoy today.

## **First Coordinated Tests With New P-8A Sub-Hunter Aircraft**

On 15 September, the bridge watch team aboard the guided-missile destroyer USS Laboon (DDG 58) watched as a P-8A Poseidon executed low level surveillance rigs at 500 feet with a speed of more than 300 knots. This was the first coordinated test evaluation and training conducted between a surface ship and the new anti-submarine warfare (ASW) platform on the East Coast.

USS Laboon crewmembers had control of the Poseidon for four hours providing safety of flight and a point of reference as they conduct radar and combat systems testing. The testing was part of establishing a maximum target detection range of various radar modes against a surface combatant.

"It was a really great feeling to be in control of an aircraft that is going to be the next best thing in the ASW world. You don't get this kind of opportunity every day," said Operation Specialist 2nd Class Michelle White, the ASW tactical air controller monitoring the Poseidon and who kept in constant communication with the aircraft and helped it navigate through air traffic.

"This P-8A test team and fleet coordinated test event brings the Poseidon one step closer to Initial Operational Capability in 2013," said Neal Rothback deputy program manager for the P-8A program.

The Poseidon, developed by Boeing Defense, Space & Security in 2009, is modified from the Boeing 737 and has the capabilities to drop and monitor sonobuoys. Its main mission is ASW and carries an armament of torpedoes, depth charges, anti-ship missiles, and other weapons. The Poseidon is equipped with an APY-10 radar as well as an ALQ-218 ESM system along with a camera that takes high definition videos

### **Piers provide entry to usable seaports**

NORFOLK, Va. In just 10 days, the Navy SEABEES have constructed an elevated causeway that is about 80-percent complete. The causeway or pier can enable a task force to receive and ship supplies anywhere, without a usable seaport.

Made from heavy steel the structure is built in sections or pontoons. "They're basically 20-foot long pontoon cans. They're eight feet wide, weigh a little over 20-thousand pounds each," said CPO William Haynes with the Navy SEABEES.

The sections are held in place with huge steel pylons that have to be driven into the seabed with a large crane. This combination of steel enables the causeway to support the weight of just about any piece of equipment or heavy containers the amphibious fleet is tasked with bringing ashore.

"Once it's fully constructed, we can transport up to 400-500 containers a day, about 20-foot containers from the ships to the shore," said **Lt Matt Manskar** also with the SEABEES.

The causeway is also much faster than relying on a vessel to bring everything to a beach. In a large scale humanitarian effort the efficiency of a causeway could mean the difference between life and death.

All it takes is two weeks of crews working two, 12 hour shifts a day to complete the project. "That's what we're here for. We're SEABEES. We build, we fight," added CM1 Eric Riley. In 2003 the SEABEES constructed an elevated causeway in Kuwait for the 'surge' in Iraq. The causeways are taken apart and removed when the mission is over. The SEABEES said it takes even less time to take one apart than it does to build one.

## **Hawk's Nest New Feature**

### **Here's Why...1**

**Ever wonder why the lowest-ranking officer in the U.S. Navy is called an Ensign, while other services use the rank of Second Lieutenant?**

Well...the word "ensign" dates to medieval times when Lords honored their squires by allowing them to carry the ensign, or banner, into battle. Later, these squires became known by the name of the banner itself, according to Naval History and Heritage Command.

In the American Revolution, the Continental Army used "ensign" to refer to its lowest-ranking officers; they, the squires of old, would one day lead troops into battle.

The rank had disappeared by the Civil War, with the job of carrying the banner reverting to enlisted members, according to "The Story of the Noncommissioned Officer Corps", a publication of the Army's Center of Military History.

In the mid-19th century, the U.S. Navy adapted the rank of Ensign as the title for its junior commissioned officers.

**Age 65 – Medicare / TRICARE**

What does a military retiree need to do when he/she turns age 65? TRICARE and Medicare are separate programs.

Medicare is health insurance for people age 65 or older as well as people under age 65 who qualify for Social Security disability insurance.

TRICARE for Life (TFL) is TRICARE's Medicare-wraparound coverage and is available to all Medicare-eligible TRICARE beneficiaries, regardless of age or place of residence. In order to be covered by TFL, beneficiaries must have both Medicare Part A (hospitalization) and Part B (medically-necessary services like doctors' services, outpatient care, home health services, and other medical services) coverage.

For TFL beneficiaries, Medicare is the primary insurance and TFL acts as the secondary insurance, minimizing out-of-pocket expenses. TRICARE covers Medicare's coinsurance and deductible charges. After Medicare pays its part of the claim, TFL pays the remaining amount for any TFL-covered services and the beneficiary pays nothing. As the primary payer, Medicare approves health care services for payment.

While there is no enrollment fee or paperwork associated with TFL, beneficiaries must sign up with Medicare. Shipmates are encouraged to enroll in Medicare as soon as they become eligible to avoid late-enrollment penalties. There is a standard monthly premium for Medicare Part B coverage, but some beneficiaries may pay more depending on their income.

**Retirees Getting (Re-)Married??**

Retirees who marry or re-marry must notify the Defense Finance & Accounting Service (DFAS) to properly establish Survivor Benefit Plan (SBP) coverage within one year of the marriage. Getting a military ID card and entering the new spouse in the Defense Enrollment Eligibility Reporting System (DEERS) does not update pay records at DFAS or trigger SBP coverage.

Retirees who originally elected SBP coverage for a previous spouse must send DFAS a copy of the marriage certificate together with a completed DD Form 2656-6 (SBP Election/Change) available online at:

Naval Station Great Lakes is celebrating its 100th anniversary this year.


